### Investors by Country of Residence

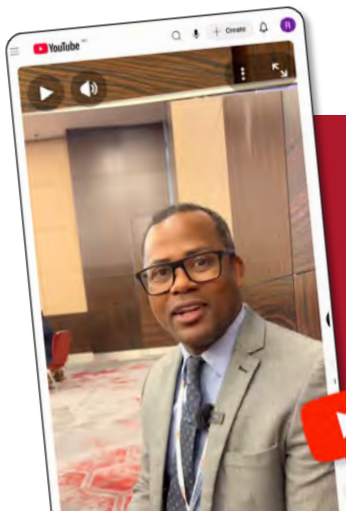
